If you use Turbo Tax, it is recommended that you contact Turbo Tax to determine if your information was collected by the hackers and for more guidance on keeping your Turbo Tax information secure.

## TurboTax Hit with Cyberattack, Tax Returns Compromised

FROM THE MEDIA: In a breach disclosure letter filed with the Office of the Vermont Attorney General and provided to its customers, Intuit says it suffered a credential stuffing attack leveraging user credentials from "a non-Intuit source" to collect income tax return data belonging to TurboTax users. If attackers successfully log into a compromised TurboTax account, they will have access to a wide range of personally identifiable information (PII) such as names, Social Security numbers, addresses, birthdates, driver's license numbers, and financial data (e.g., salary, deductions). Intuit says after identifying the breach during a system security review, it temporarily suspended all impacted accounts to prevent further compromise. Intuit is also offering affected customers one year of free credit monitoring through Experian IdentityWorks.
